### Preamble

This Memorandum of Understanding (MOU) is made on 03 July 2023, between Maa Bharti P.G. College, Kota (hereinafter referred to as "MBPG") and Government College, Kota (hereinafter referred to as "GCK"). This MOU sets forth the intentions of both parties to increase collaboration, cooperation, and interaction for the mutual benefit of their academic and research pursuits.

### Purpose

The purpose of this MOU is to establish a framework for collaboration between MBPG and GCK in areas of mutual interest, leveraging the strengths and expertise of both institutions to enhance educational and research opportunities.

### Scope of Collaboration

The collaboration between MBPG and GCK may include, but is not limited to, the following areas:

Joint Research Projects: Collaborative research projects in fields of mutual interest.

Academic Exchange: Exchange of researchers, and students for academic and research purposes.

Workshops and Seminars: Joint organization of workshops, seminars, and conferences.

Resource Sharing: Sharing of academic resources, including libraries, laboratories, and other facilities.

Publication and Dissemination: Joint publication of research findings and dissemination of knowledge through various channels.

### Terms and Conditions

**Duration and Termination:** This MOU will remain in effect for a period of 3 years from the date of signing. It may be extended or terminated by mutual consent of both parties. Either party may terminate this MOU by giving 1 months' written notice to the other party.

**Funding:** Each party will be responsible for its own costs and expenses incurred in connection with the activities under this MOU unless otherwise agreed upon in writing.

**Confidentiality:** Both parties agree to maintain the confidentiality of any proprietary information shared during the collaboration.

**1. Preamble**

**2. Scope**

**3. General Provision**

- a. Upon mutual approval by both partners, this agreement shall remain in effect for a period of three years, unless terminated by either partner.
- b. Unless otherwise agreed upon by the partners, the termination of this MOU shall not affect the implementation of ongoing activities and / or program, which has been agreed upon by the date of termination of the MOU

**MEMORANDUM OF UNDERSTANDING****BETWEEN****IHOIK CARE****AND****MAA BHARTI PG COLLEGE**

This non-binding Memorandum of Understanding ("MoU") is entered into on the 7th day of June, 2024, by and between:

1. **IHOIK CARE (A unit of IHOIK Media)**, being a social service organisation, and having its registered office at Tripolis, New Rajiv Gandhi Nagar Kota, Rajasthan (324005), acting through its authorized signatory, Mr. Anshu Maharaj (hereinafter referred to as "**IHOIK**", which expression shall unless excluded by or repugnant to the context or meaning thereof, include its successors and permitted assigns), **OF THE FIRST PART;**

**AND**

2. **Maa Bharti PG College**, being an educational institution, and having its registered office at Near Mahaveer Nagar III Circle, Mahaveer Nagar Kota, Rajasthan - 324005, India, acting through its authorized signatory, Dr. Shweta Saxena (hereinafter referred to as "**Party B**", which expression shall unless excluded by or repugnant to the context or meaning thereof, include its successors and permitted assigns), **OF THE SECOND PART.**

As the context may require, IHOIK Care and the Party B shall hereinafter collectively be referred to as "**Parties**" and individually as a "**Party**".

**WHEREAS:**

- A. IHOIK Care is primarily engaged in rendering non for profit social services to underprivileged sections of the society.
- B. Party B is engaged in the business of rendering education to Graduate students.
- C. Both the Parties are exploring potential areas of collaboration by combining their skill sets along with their technical, material and human synergies for inter alia humanitarian efforts, on-ground social work and enablement of the underprivileged.

**NOW THEREFORE, IN CONSIDERATION OF THE COVENANTS SET FORTH IN THIS MOU AND FOR THE GOOD AND THE VALUABLE CONSIDERATION, THE ADEQUACY OF WHICH IS HEREBY ACKNOWLEDGED, THE PARTIES HEREBY AGREE AS FOLLOWS:**

**1. PURPOSE**

The Parties agree to collaborate with each other, on a founder-to-principal basis, with respect to the following 'Purpose and Areas of Collaboration' as detailed below, on the principles of utmost good faith ("**Purpose**");

**Purpose and Areas of Collaboration:**

- (i) Explore the enablement of the underprivileged section of the society.





- (ii) Promote Parties efforts in physical and digital domain.

## 2. CONTRACT AND FINANCIAL ARRANGEMENTS

- 2.1. Depending on the type of assignment or project to be done in collaboration, the Parties will agree the most suitable setup for the execution, either as a joint venture or with a clear demarcation of scope and responsibilities.
- 2.2. All financial arrangements of the joint projects and the payment terms will be initially discussed and agreed mutually in advance by both the Parties on a case-to-case basis as per requirements of the project.
- 2.3. A Party may not commit the other Party to any costs, expenses and/or obligations without the prior written consent of that Party.
- 2.4. Nothing contained in this MoU shall be construed as allowing for the sharing of the profits or losses of any Party (arising out of the actions/efforts of such Party to this MoU) by the other.

## 3. ROLES AND RESPONSIBILITIES

- 3.1. Parties shall fully cooperate and coordinate with each other and take all necessary steps to ensure that the Purpose is successfully achieved.
- 3.2. The Parties shall work together to explore areas of collaborations in different projects for which the Parties shall, as and when required, execute separate detailed tasks.

## 4. CONFIDENTIAL INFORMATION

- 4.1. Each Party shall take all necessary steps and do all such necessary things to protect the Confidential Information (*defined hereinafter*) of the other Party. The Parties shall not disclose any Confidential Information to any third person, except to its employees, contractors, and other agents who have a need to know and who have been bound in writing to obligations of confidentiality no less restrictive than those contained in this MoU. The Parties shall not use any Confidential Information for any purpose outside the scope of this MoU.
- 4.2. The confidentiality provisions of this MoU shall remain in full force and effect during the MoU and shall survive the termination or expiration of this MoU.
- 4.3. For the Purposes of this MoU, "**Confidential Information**" shall include all non-public information disclosed by one Party to the other Party, whether orally or in writing, that is designated as confidential or that reasonably should be understood to be confidential given the nature of the information and the circumstances of disclosure. Confidential Information shall include, but shall not be limited to project plans, future prospects, campaign strategies, financial information, and any Intellectual Property Rights or proprietary information.

## 5. TERM AND TERMINATION

- 5.1. This MoU shall commence as of the Effective Date, first written above and shall remain in effect for a period of 1 year(s), from the Effective Date i.e., till 08th June, 2025. ("**Term**").
- 5.2. The Term of this MoU shall thereafter be renewed upon such terms and conditions as may be mutually agreed to by both the Parties, in writing.
- 5.3. Either Party may terminate this MoU at any time upon 5 (Five) days written notice to the other Party. The provisions of Clause 4 (Confidential Information), Clause 6 (Non-Solicitation) and any other provisions which by their nature are intended to survive termination, shall survive termination of this MoU.



## 6. NON-SOLICITATION

- 6.1. The Parties shall not, either themselves or through their affiliates, associates, partners, licensees, agents, shareholders, directors, during the term of this MoU and 1 (one) year thereafter, approach, induce or attempt to approach, implement or induce any prospect/project that the Parties may have approached jointly in pursuance of this MoU.
- 6.2. Further, no Party shall approach a project/prospect who has been referred to by the other Party without the explicit written consent of such other Party.

## 7. MISCELLANEOUS

- 7.1. **Notice(s):** Any notice or other communication under this MoU will be in writing and will be sent by electronic email as follows:

- 7.3. **Non-Binding:** Except for Clause 4 (Confidential Information) and Clause 6 (Non-Solicitation) the provisions of this MoU are non-binding and do not create any binding obligations or commitments on either Party. The Parties acknowledge that they are not entering into a partnership, joint venture, agency or any other type of formal business relationship through this MoU.
- 7.4. **No Exclusivity:** This MoU does not grant any exclusivity to either Party. Each Party is free to explore collaborations & relationships with other parties.
- 7.5. **Governing Law:** This MoU shall be governed and construed in accordance with the laws of India.

**C. MAA BHARTI P.G. COLLEGE, KOTA ON ITS PART:**


1. To provide students and staff conducting training and other activities to IGTR, Indore.
